We use this information to verify registration and/or product offerings. We use some of the optional information to help us provide statistics to guide the company (i.e. who is visiting us and from where) so that we can better reach people and invite them to the use these sites.

### **3. What do we not do with the information?**

We don't sell your identity to any third parties. We don't sell your information you place on our sites to any third parties.

### **4. Cookies and IP Addresses**

There is additional information that can be gathered by an operating web site. One is the IP address (random numbers assigned to individual computers) of the machine you use to reach these sites. This information is used to help diagnose problems with our web sites.
